

(March 15, 2022 meeting, in preparation for Senate meeting of March 23, 2022)

1. APPROVAL OF MINUTES OF SENATE

5. REVIEW OF QUESTIONS AND MOTIONS

The Committee received one motion for the Senate meeting of March 23, 2022.

The motion (submitted by Senators Downie, Low, Nystrom, Poorhemati, Shor, and Subramanian) called for the creation of a Senate-Board Conference Committee on Fossil-Fuel Divestment. The Committee noted that when the motion was first submitted in March 2020, at the beginning of the pandemic, it was agreed that questions and motions on non-urgent matters and requiring a full discussion at Senate could be deferred, as determined by the Steering Committee, for consideration when in-person meetings resume. In light of the importance and complexity of this motion, the Committee agreed to consider it at its next meeting, in April, when it was expected that the Committee would meet in person. The Committee was of the opinion that an in-person discussion on the matter is necessary given the importance of the issue raised.
